Camp Director's

Ham Munnell is returning for his 21st year as Director of the Crimson Tide Wrestling Camp. Coach Munnell is currently in his 21st year as Head Wrestling Coach at Concord High School. He was selected NH Division I Coach of the Year in 1997 and 2000. During his tenure as Head Coach he led Concord to 3 Class L State titles in 1997, 1998, and 2000. Also Dual Meet State Champions in 2008. He was named Concord Monitor Coach of the Year in 1998. In 1990 Ham was an NCAA Division 1 ~ All American Wrestler and Miami University 2014 HOF Inductee. Coach Munnell brings a great love of wrestling to the camp, which is quickly apparent to all.

Nick Zeras

Nick (Tiny) returns for his 20th year to the Camp. Nick teaches Physical Education at Broken Ground School. Nick was Concord's State Champion in 1997, Captain of the 1998 State Champion Team for Concord, and wrestled for Boston University 1999-2002. He also is 2005-06 and 2006-07 NWCA NH Asst. Coach of the Year.

Senior Staff

Chrigus Boezeman was an individual State Champion for Concord in 2000 as well as Captain of the 2000 CHS Wrestling team that won the Class L Title. Chrigus also has several coaching distinctions. He was 2003 Middle School Coach of the Year. He has also coached CHS Freshman to State Titles in 2004, 2005, 2006, 2010 and the JV team to titles in 2005, 2006, 2007 and 2008.

Scott Owen is the Rundlett Middle School Wrestling Director as well as the Concord High School Baseball Coach. His organizational skills and ability to work with younger wrestlers are a great asset to the camp. He also was a 2X Middle Coach of the Year. He led them to the 2005 Middle School State Championship.

Steve Shippos is currently a Teacher and Head Wrestling Coach at Rundlett Middle School. Steve is a 2X New York State Champion. While wrestling at Bloomsburg University he was a 2X NCAA National Qualifier and a two time University National All-American (freestyle). He also led the Rundlett Middle School team to 3 State Titles (2011, 2012, 2013).

Dan Breen is returning for his 11th year as the Head Counselor for the Crimson Tide Wrestling Camp Red Dragons. During Dan's CHS career he was a 2X All State Wrestler, All State Runner-up and a New England Qualifier for Concord High School. Coach Breen was also a member of the 2007 undefeated team which defeated Timberlane for the Dual Meet State Title. He has been an Assistant Varsity Wrestling Coach at Concord High School for the past 9 years and just graduated from Southern New Hampshire University with his High School teaching certificate.

Shawn Moseley - NH All State Champion - Wrestled at Plymouth State - Teacher and Coach at Rundlett Middle School.

Bob Daniels - 2X NH All State Champion - 5th Place in New England - Educational Assistant at Concord High School.
